# Before You Start

## Entry requirements

The NEBOSH Level 6 Diploma requires a foundation level of health and safety. You should already have a confident understanding of key principles, including risk assessment, accident investigation, and health and safety regulation. You'll also need to have good writing skills and be able to critically analyse information.

We always recommend taking the NEBOSH General Certificate, or having least 5 years of experience working in a health and safety role before taking the NEBOSH Level 6 Diploma. That way you'll have the right level of knowledge to meet the demands of the course.



## Before You Start

### National vs International: Which one is right for you?

The NEBOSH Level 6 Diploma is available in two versions: National and International.

Both follow the same syllabus and have the same learning outcomes, but they reference different regulations in the details.

#### NEBOSH Level 6 National Diploma

The NEBOSH Level 6 National Diploma is guided by UK legislation and enforcement agencies. This includes the Health and Safety at Work etc. Act 1974, Health and Safety Executive (HSE) and Crown Prosecution Service (CPS).

If you work in the UK, then the National version will make sure you're working to British standards and global best practice.



#### NEBOSH Level 6 International Diploma

The NEBOSH Level 6 International Diploma takes a broader approach based on best practice and international standards, including the International Labour Organisation (ILO) codes of practice. It covers local laws and cultural factors when appropriate.

If you work outside the UK, then the International version will be more helpful.

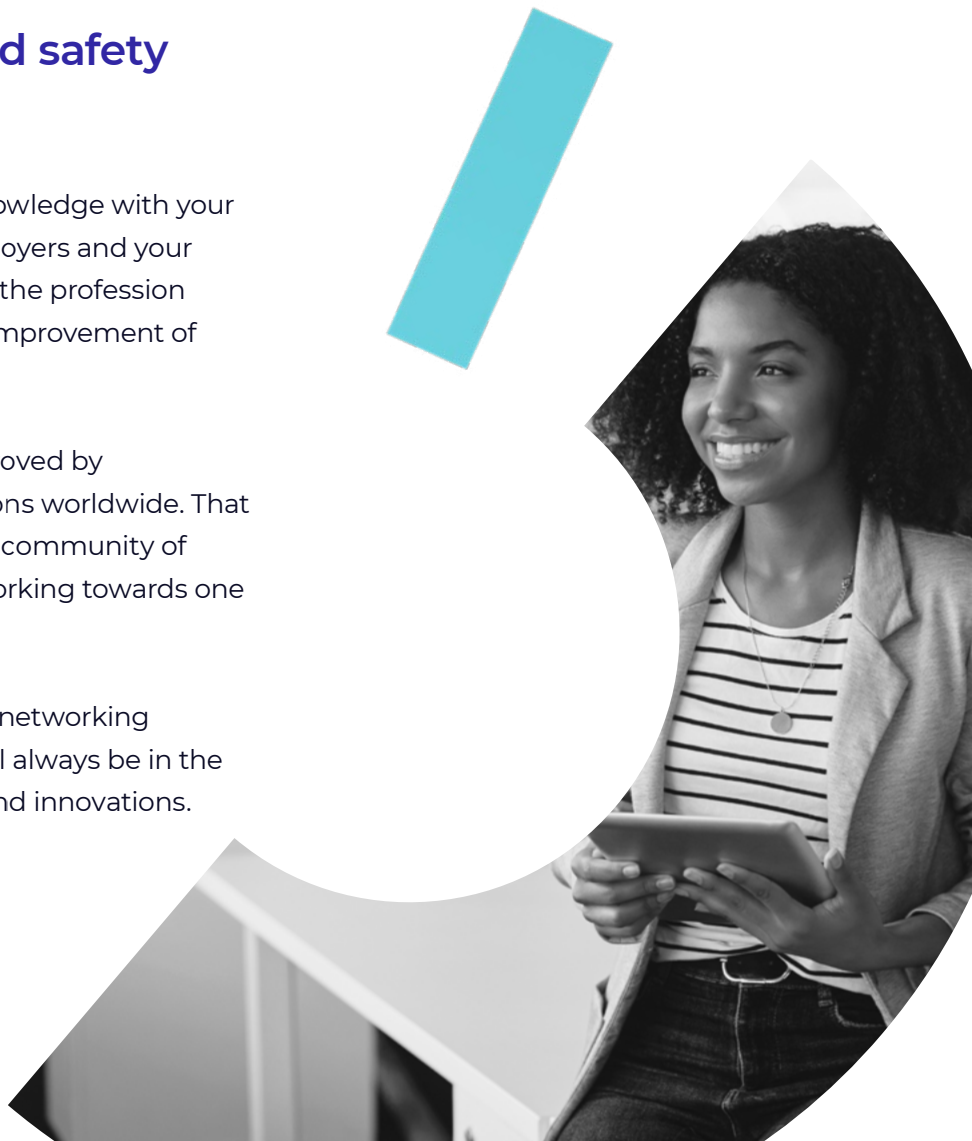

## Course level

The NEBOSH Level 6 Diploma is recognised as a level-6 vocational qualification on the UK Regulated Qualification Framework (RQF) and Qualifications and Credit Framework (QCF).

In the Scottish Credit and Qualification Framework (SCQF), it's recognised as a level 10 with 48 credit points.

In South Africa, it's recognised as a level 8 worth 120 credit by the South African Qualification Association (SAQA).

# Course Overview

## Learning outcomes

The NEBOSH Level 6 Diploma has 11 learning outcomes. By the end of the course, you'll be able to:

- 1 Source, develop, evaluate and interpret relevant health and safety information (such as legislation, guidance, best practice, procedures) and communicate it effectively to those who need it.
- 2 Promote a positive health and safety culture by influencing leaders and changing attitudes and behaviour.
- 3 Assess, develop and maintain individual and organisational health and safety competence.
- 4 Understand risk management, including the techniques for identifying hazards, the different types of risk assessment, considerations when implementing sensible and proportionate additional control measures, and developing a risk management strategy.
- 5 Develop and implement proactive and reactive health and safety monitoring systems and carry out reviews and auditing of such systems.
- 6 Continually develop your professional skills and ethics to actively influence improvements in health and safety by providing persuasive arguments to workers at all levels.
- 7 Develop a health and safety policy strategy within your organisation (including proactive safety, Corporate Social Responsibility and the change management process).
- 8 Contribute to health and safety legal actions.
- 9 Manage contractors and supply chains to ensure compliance with health and safety standards.
- 10 Advise the organisation on a range of common workplace health issues/ hazards, including how these can be assessed and controlled and the legal duties associated with these issues/ hazards.
- 11 Advise the organisation on a range of common workplace safety issues/ hazards, including how these can be assessed and controlled and the legal duties associated with these issues/ hazards.

# Assessment

The NEBOSH Level 6 Diploma is assessed entirely through practical activities and scenario-based questions.

Each assessment is completed digitally and submitted to the NEBOSH portal for marking.

## Assessment format

Unit 1 is an assignment split over two papers. Both papers must be submitted at the same time.

- ▶ **Paper 1:** Simulation questions
- ▶ **Paper 2:** Workplace activities, reflective tasks and a research project

NEBOSH recommends you spend around 40 hours on your DN1/D11 assignment. You will have 4 weeks to complete your assignment and submit it electronically.

Units 2 and 3 are each assessed with a case study and scenario based questions. NEBOSH recommends you spend around 20 hours on each assessment paper. You will have 2 weeks to complete each assessment and submit it electronically.

## Pass rates

You must achieve a pass in all three units to achieve your full NEBOSH Level 6 Diploma. Once you've passed all units, your marks will be added together and you'll be awarded your final qualification grade.

150 - 195 marks

**Credit**

196 - 255 marks

**Distinction**

256+ marks

# Assessment

## Exam dates

All NEBOSH Level 6 Diploma assessments are open-book assessments. The assessment registration opens twice a year.

The registration for the exam is typically 8 weeks before the assessment start date. For example:

Unit	Registration Date	Assessment Start Date	Submission Deadline
DN1/DI1	July	September	4 weeks later
DN2/DI2	September	November	2 weeks later
DN3/DI3	May	July	2 weeks later

**DN1/DI1:** You will have 4 weeks to complete your assignment and submit it to the NEBOSH online portal. We recommend you spend at least 40 hours on your assessment, which equates to around 10 hours per week.

**DN2/DN3/DI2/DI3:** You will have 2 weeks to complete each question paper and submit it for marking. We recommend you spend at least 20 hours on each paper, which equates to around 10 hours per week.

## Exam results

NEBOSH will email you your results within 12-14 weeks of sitting your exam. If you haven't received your results in that time then contact your course provider. They'll be able to help.

Your hard copy certificate will be sent out shortly after receiving your results. It will display your final qualification grade - pass, credit or distinction.
